Ownership and License

CONEXPO-CON/AGG 2014 and IFPE 2014 are the sole and exclusive lawful owner of all right, title, and interest, in the CONEXPO-CON/AGG 2014 and IFPE 2014, name, logo, trademarks, service marks, and the List and all related materials. CONEXPO-CON/AGG 2014 and IFPE 2014 hereby grants to Exhibitor a one-time, limited, conditional, non-exclusive, non-transferable license to use the List in accordance with the terms of this Agreement. This license does not convey, transfer, or assign to the Exhibitor ownership or any other rights from CONEXPO-CON/AGG 2014 and IFPE 2014 to Exhibitor. In the event the Exhibitor becomes aware of any infringement or unauthorized use by any third party of the List or related materials licensed under this Agreement, the Exhibitor shall promptly notify CONEXPO-CON/AGG 2014 and IFPE 2014 in writing of such infringement or use.

Limitations on Use

Exhibitor may use the List for purposes of promotional mailing directed to CONEXPO-CON/AGG 2014 and IFPE 2014 attendees. CONEXPO-CON/AGG 2014 and IFPE 2014 shall have the right to review and approve all such promotional mailings by Exhibitor, but will not unreasonably delay or withhold such approval. Exhibitor may not use the List for any other purpose (including, but not limited to, distribution, sublicensing, selling, renting, or leasing the List). Exhibitor agrees that it will not exploit such license to the detriment of the name and goodwill of CONEXPO-CON/AGG 2014 and IFPE 2014. CONEXPO-CON/AGG 2014 and IFPE 2014 will seek all appropriate legal remedies from any person or party who violates its rights in the List. Phone numbers and e-mail addresses are not included in the pre and post show lists.

Term

The term of this Agreement shall commence upon acceptance by CONEXPO-CON/AGG 2014 and IFPE 2014 and shall continue in effect until March 1, 2014. Exhibitor's license and this Agreement shall terminate upon fraud, willful misconduct, or breach of this Agreement by Exhibitor. Upon any termination or expiration of this Agreement, Exhibitor shall destroy (or return if requested by CONEXPO-CON/AGG 2014 and IFPE 2014) the List and any related materials provided under this Agreement and maintain no copies or duplicates in any medium without the express written approval of CONEXPO-CON/AGG 2014 and IFPE 2014.

CONEXPO-CON/AGG 2014 and IFPE 2014 Show Rules and Regulations

Indemnification
