Aisle Carpet Surf Expo uses 9' wide aisle carpet in each 10' wide aisle. Please plan accordingly when

constructing your booth.

Childcare Anyone under the age of sixteen (16) will not be admitted into Surf Expo. Surf Expo does

not provide onsite childcare.

Exhibitor Move- In All exhibitors will move in from 8 am – 6 pm** on Tuesday, January 7 and from 8 am – 6 pm** on

Wednesday, January 8, 2014.

**All hall doors for exhibitor move-in will be closed at 6 pm. Exhibitors already in the hall may continue to set-up until 8 pm. All crates must be unpacked and labeled for removal no later than 3 pm on Wednesday, January 8. This is to facilitate the installation and cleaning of aisle carpet. All exhibits must be fully assembled and operational by 8 am Thursday, January 9, 2014.

Exhibitors will be allowed in the hall at 7 am and the show opens to all buyers at 9 am.

Exhibitor Move-Out Exhibits officially close at 4 pm Saturday, January 11. We ask that no exhibits/displays be

dismantled, packed or removed before the official close of the show. Buyers are on the floor until 4, don't lose the opportunity for a sale and please show respect for your neighbors by honoring the official show close. Empty crates/containers are delivered once the aisle carpet is removed; please assist in this effort by keeping the aisles around your booth clear. **All carriers**

must be checked in by 10 am Monday, January 13, no exceptions.

the Service Center.

No Freight Aisles All items left in the *no freight aisles* will be moved into the booth by GES, the official Service

Contractor.

Any changes made after 7 pm Wednesday, January 8 will result in a \$50 change fee per badge.

All booths must be set up no later than 8 am on Thursday, January 9. Show management will utilize all unclaimed booths at our discretion.

Appointments may be scheduled as early as 8 am. The attendee **must** have a badge and be met at the entrance by the exhibitor with whom they have the appointment.

Exhibits must remain intact until 4 pm the last day of the show.
