

PROOF OF INSURANCE -----

REQUIRED FOR ALL EXHIBITORS

Insurance Requirements

Deadline: May 9, 2014

Your company and any outside contractors that you hire for the trade show will be responsible for claims arising out of your use of the premises of the Mandalay Bay Convention Center, including but not limited to the installation and dismantling of your display.

The Mandalay Bay Convention Center requires that your company and any outside contractors that you hire agree to obtain and maintain Comprehensive General Liability Insurance during the use of the premises. Such insurance shall be in the amount of not less than \$1,000,000 per occurrence, \$2,000,000 in the aggregate for General Liability. Licensing Expo 2014, Advanstar Communications, Inc., Mandalay Bay Corporation and Mandalay Bay Resort Group shall be named as additional insureds on such policy, and your company and any outside contractors that you hire shall supply Advanstar Communications Inc. and Licensing Expo 2014 with Certificates of Insurance at least thirty (30) days prior to the use of the premises.

Exhibitors and their outside contractors assume responsibility and agree to indemnify and defend Licensing Expo 2014 and Advanstar Communications Inc. and their respective employees and agents against any claims or expenses arising out of the use of the exhibition premises.

Exhibitors and their outside contractors understand that neither the Mandalay Bay Convention Center nor Licensing Expo 2014 and Advanstar Communications Inc. maintain insurance covering the exhibitor's property and it is the responsibility of the exhibitor to obtain such insurance.



IF YOU DO NOT HAVE GENERAL LIABILITY COVERAGE:

Exhibitors who do not have general liability coverage or cannot obtain the required certificate of liability insurance as required by show management from their current provider may purchase a temporary policy from Wells Fargo Insurance Services. Well Fargo Insurance services can provide insurance coverage for the duration of Licensing Expo 2014 that meets all show management insurance requirements.

FREQUENTLY ASKED QUESTIONS REGARDING WELLS FARGO INSURANCE SERVICES

Should I notify Advanstar/Licensing Expo that I have purchased insurance with Wells Fargo?

Notification is not necessary if purchased through Wells Fargo Insurance Services. They will notify Advanstar/Licensing Expo of all payments and applications received.

What if I have my own insurance?

If you have your own insurance, please use the link in the email you will receive from Wells Fargo to provide the insurance information and a Certificate of Insurance.

Can I order the insurance online?

Yes, insurance services can be ordered through Wells Fargo. Contact tradeshow@wellsfargo.com.

What company name should I put on the application?

The name under which you are registered with Licensing Expo 2014. If your booth will reflect a different name, be sure to include that on the application as well.

What should I fill in for "Individual Contact"?

The name of any person who would be able to answer questions pertaining to your participation in Licensing Expo 2014.

Will the insurance cover theft and/or damage to my property?

NO. This is third party liability insurance only. it applies when someone claims you caused bodily injury or property damage. You should rely on your own business insurance to cover your exhibit and its contents at the show and in transit.

How long is the insurance valid?

Insurance will cover only the immediately-ensuing show. For example, if the documentation is received between now and June 2014, the show coverage will be for the June 2014 show only.

When do I need to send the application and payment?

As early as possible. To avoid penalties imposed by Advanstar absolutely no later than 30 days prior to the move-in date of the show in which you will participating.

How will I know when the application and payment have been received?

You will receive automatic confirmation of coverage via receipt when purchased online with a credit cart.

Is the insurance refundable?

No. All sales are final. No refunds will be issued once payment has been submitted. No exceptions.
