



Exhibitor Liability Insurance Program

As a standard requirement for all of our show exhibitors, it is necessary for you to carry general liability coverage from an insurance company in good standing with minimum policy limits of \$1,000,000 per occurrence and \$2,000,000 aggregate. Association of Equipment Manufacturers, Las Vegas Convention Center, National Ready Mixed Concrete Association, The National Stone, Sand & Gravel Association and National Fluid Power Association shall be named as additional insured. This insurance must be in force during the lease dates of the event.

Purchase your Insurance Now

There are no applications to fill out. Simply purchase your insurance, which is already pre-filled with all of the proper show information, directly online using a credit card.

We have set up two Insurance Programs for this show.

Your coverage must include your move in and move out dates.
