Airport / Port of Arrival	Advance Warehouse	Direct to Show
Airfreight: LAS Airport	February 14, 2018	5 days prior to target move-in
Ocean: Long Beach CFS	February 8, 2018	12-14 days prior to target move-in

We require our ISF-10 form completed and sent to us 72 hours prior to vessel departure. GES will NOT be able to make entry for any incorrect or late ISF-10 form. A full pre-alert with AWB or B/L, CIPL, flight or vessel information, and any other pertinent documentation must be sent to GES at least **2 business days** prior to airfreight shipment arrival in U.S. airport, and **5 business days** prior to ocean shipment arrival to U.S. port.
