Exhibitors 1000 sq. ft. and larger crates returned no later than Thursday, August 15, 2019 - 8 a.m. All outbound material must be packed, labeled, and carrier checked in by your corresponding target.

- All booth packages will be available for merchandising Sunday, August 11, 2019, 8:00 a.m.
- All meeting room and lobby exhibitors move-in date Friday, August 9, 2019, 8:00 a.m., move-out Thursday, August 15, 2019, 1:00 p.m.
- All requests for target changes must be submitted in writing via the Request for Variance Assigned Target Time Form (R-23) located in the exhibitor manual.
- **PRODUCT ONLY** may arrive on or after your target date and is not subject to off-target surcharges. This does NOT include Furniture, Accessories, Flooring or Structure. These need to stay on Target. For security purposes, it is strongly recommended that your product not arrive prior to Saturday, August 10, 2019. It is also recommended that someone be in your booth to receive and secure your product once it is delivered.
- All crates must be empty and labeled for removal no later than Saturday, August 10, 2019, 10:00 p.m. All crates labeled or not will be removed from the building at this time.
- Target times are for freight arrival only. It is recommended that you schedule labor to begin the day after your target date/time.

Set-up for all exhibitors may begin as soon as freight is received in your booth.
Each in-line exhibitor must provide a 9" electrical access behind booth.
Each perimeter booth must provide an 18" electrical access behind booth.
Advance freight sent to the GES warehouse will be delivered to the booth no later than the published target date/time.
Refer to "Exhibitor Set-Up Move Manual" for schedule booth installation rules.

Marshaling Yard Hours:

Marshaling yard hours of operation are provided for your convenience. Drivers must check-in at the marshaling yard no later than 2pm to guarantee same day unloading.

Please note, if your shipment does not arrive by your target time, you may be charged a 25% surcharge on your drayage. A 25% surcharge also applies if your shipment is not picked up by your target time on the move-out.
