**EXHIBITOR CERTIFICATE OF INSURANCE  
INFORMATION**

**INSURANCE REQUIREMENTS**

All Exhibitor must secure, maintain and submit proof of the following insurance during set-up, show hours, and tear-down. It should be prepared by an insurance agent and include the following data, as per the sample included in this section.

1. **PRODUCER:** Insurance Agent/Broker who issues the certificate
2. **NAME OF INSURED:** Must be the legal name of the contracting party
3. **TYPES OF INSURANCE:** Must include types required by contract
4. **FORM OF COVERAGE:** Must be "occurrence" form of coverage
  
5. **CERTIFICATE HOLDER:** Must be listed as:

6. **POLICY EFFECTIVE DATE:** Must be prior to or coincidental with the first day of Exhibitor Move-In. (Thursday, November 19<sup>th</sup>, 2020)
7. **POLICY EXPIRATION DATE:** Must be on or after the last day of Exhibitor Move-Out. (Tuesday, November 24<sup>th</sup>, 2020)
8. **LIMITS OF INSURANCE:** Must be the same or greater than required by contract.

✓ Comprehensive General Liability and Property Damage Liability Insurance including Damage to Rented Premises and Personal & Adv Injury limits, not less than one million dollars (\$1,000,000) per occurrence and two million dollars (\$2,000,000) aggregate.

✓ Medical Expenses for any one person of no less than ten thousand dollars (\$10,000).

✓ Automobile Liability on Any Auto, Hired Autos and Non-Owned Autos with limits no less than one million dollars (\$1,000,000) combined single limit – each accident.

✓ Umbrella Liability Insurance not less than one million dollars (\$1,000,000) per occurrence and one million dollars (\$1,000,000) aggregate.

✓ Workers' Compensation Insurance in full compliance with all laws covering the contractor's employee in the state for which this event is being held, or for where the work is being performed, or of the state in which vendor is obligated to pay compensation to employees engaged in the performance of the work. Employer's Liability Limits of not less than one million dollars (\$1,000,000) each accident.

9. **ADDITIONAL INSURED:** The following should be listed under DESCRIPTION OF OPERATIONS/LOCATIONS/VEHICLES/SPECIAL ITEMS:

UBM / INFORMA MARKETS (SHOW MANAGEMENT), THE AESTHETIC SHOW (SHOW); GES (OFFICIAL SERVICE CONTRACTOR); THE WYNN LAS VEGAS. LLC, THEIR OFFICERS, AGENTS & EMPLOYEES, FREEMAN, THEIR OFFICERS, AGENTS AND EMPLOYEES ARE INCLUDED AS ADDITIONAL INSURED. IT IS FURTHER AGREED THAT THIS INSURANCE IS PRIMARY TO ALL OTHER SIMILAR COVERAGE CARRIED BY THE WYNN LAS VEGAS. LLC AND THE LICENSEE AND THEIR INSURANCE SHALL HAVE NO RIGHT OF RECOVERY OR SUBROGATION AGAINST THE LICENSOR. COVERAGE MAY NOT BE CANCELED OR A MAJOR CHANGE IN COVERAGE MAY NOT BE IMPLEMENTED WITHOUT AT LEAST THIRTY (30) DAYS PRIOR WRITTEN NOTICE GIVEN TO LICENSOR. PRIMARY AND NON-CONTRIBUTORY ON ALL POLICIES EXCEPT WORKERS COMPENSATION.

10. **AUTHORIZED REPRESENTATIVE:** Must be signed (not stamped) by an authorized representative of Producer.
