# Sustainability

To ensure that your company and exhibiting stand are aligned with Informa's sustainability goals:

#### **Better Stands**

Did you know that one disposable stand produces the same amount of waste as four U.K. households do in an entire year? Designed to be used only once, they have a significant impact on the environment, in addition to increasing health and safety risks onsite.

Better Stands is a company-wide program aiming to ensure that all core elements of exhibitor stands are reusable. Help us to reduce the environmental impact of SupplySide Global by committing to the Better Stands regulations and show that your company values being part of sustainable and socially responsible events.

# What's in it for me?

- · A better quality, more attractive stand
- Opportunity to promote the sustainable credentials of your brand
- Smoother, more efficient build up and breakdown periods
- · Lower work hours and reduced construction costs
- Lower waste bills

## What do I need to do?

To make your commitment to Better Stands and contribute to a more sustainable event:

- 1. Read the Better Stands regulations found below.
- 2. Fill out the survey included in the **Booth Approval Form**, regarding Better Stands.
- 3. Share the regulations with your contractor and agree to a reusable stand design
- 4. Ensure that the submitted stand design clearly communicates how you will meet the Better Stands regulations





# What are the regulations?

To ensure your stand is designed in line with our Better Stands policy see the list of acceptable and unacceptable stand elements below:

#### Accepted

All core stand elements, i.e., walls, archways, counters, etc., must be constructed with reusable materials, e.g., system-built stock panels.

The stand structure must be prefabricated and ready to assemble onsite.

Final adjustments to prefabricated pieces for fitting purposes are allowed.

Final coat of acceptable TVOC paints for repair purposes only.

Floor flats and system floors must be cut to size before coming onsite and be recyclable and/or reusable.

The use of LED lighting.

The use of recycled or recyclable carpet, eco vinyl flooring or other environmentally responsible floor coverings.

### Not accepted

The use of one-time raw materials planned to be cut down to size onsite typically using chipboard, particleboard and low-density fiberboard (LDF)

The use of other raw materials to construct core structural elements, i.e., walls, archways, floor systems, counters, etc., that are not planned to be reused or recycled after use.

Construction of any stand components from single-use materials.

Building onsite from scratch any core stand elements.

The use of incandescent light bulbs.

The use of nonrecycled carpet, PVC vinyl flooring or other single-use floor coverings.

## What will we do?

To ensure that all exhibitors can meet the Better Stands regulations, we will:

- Provide a list of preferred partners with experience producing sustainable stands
- Review your stand designs prior to the permission stage and make you aware of any breaches
- · Offer help and advice to find sustainable solutions that suit your needs
