

## Registration:

The School Nutrition Association has planned an outstanding series of education sessions and General Sessions. We encourage you to attend these sessions and learn more about the Child Nutrition Industry. Each company receives five (5) complimentary badges per 10x10 booth space purchased.

Once your company goes over their badge allotment, there is a \$100 fee for additional badges. No badges, above your allotment will be processed without payment. Online Registration allows you to make changes and additions to your badge order up until the time the site closes on <a href="https://doi.org/10.10/2016/nc.10.2">Thursday, June 30</a>. After June 30, all registration must be processed on-site and the cost for additional badges increases to \$125 per badge. (Badges will not be mailed, but available for pick up on-site at the registration desk at the Henry B. Gonzalez Convention Center).

## **General & Educational Sessions:**

## **Badge Restrictions:**

No one under 16 years of age is permitted into the Exhibit Hall or on the Loading Docks at any time (no exceptions) per SNA and the Henry B. Gonzalez Convention Center! This includes family members as well as booth character personnel and applies during installation, dismantling and on exposition days (July 7 – July 14, 2016). No exceptions will be made.

The Conference Badge is for Exhibitors only! False certification of individuals as Exhibitor representatives, misuse of Exhibitor badges, or any method or device used to assist unauthorized persons to gain admission to the conference shall be cause for expelling the violators from the exhibit hall.

Food Service Professionals cannot register as an Exhibitor. If your organization is sponsoring a Food Service Professional, please complete the Foodservice Attendee Registration form. If a foodservice professional is registered with a company badge, the foodservice attendee will not receive CEUs or tickets to special events.

<u>Housing:</u> This year, there is a brand-new procedure requiring registration for ANC16 San Antonio, *before* housing will be in effect. <u>All Exhibitors must register for badges before they will be provided access to the SNA housing system</u> and the discounted rates at the official ANC 2016 hotels. This change in procedure is designed to help the Association better control the inventory of available rooms, ensuring that a greater number of exhibitors will have the opportunity to book their first-choice hotels on their preferred dates and still receive SNA's discounted rates.

- 1. You MUST register for your badge first
- 2. EPIC/Expo Logic (our official registration company) will forward you a <u>confirmation receipt</u> that will contain a confirmation number and the link to the housing site
- 3. Click on the housing site link within the <u>confirmation receipt</u> and you will be able to reserve your hotel rooms
