## EXHIBITOR SHOW-FLOOR SUITE APPLICATION

### INFORMATION AND PRICING

Custom-built hard-wall 10'x20' suites are available on the show-floor for rental by exhibiting companies. These suites can be utilized on the exhibit floor during show hours. The limited number of Exhibitor Show-floor Suites are available around the perimeter of the hall. Suites will be assigned in order of receipt of completed applications to AAOMS.



Show-floor suites can accommodate the activities such as:

- Staff Meetings
- Business Meetings
- A more private area off the main show floor for lunches, etc.
- VIP demos

The rental cost for the show-floor suite is \$3600. Payment is due upon invoice. Included in the price of the suite rental is:

- Construction of the 10x20 suite by GES, general service contractor
- 8' high hard wall with standard panels and locking door
- Carpet
- Sign with company name and logo

Additional items may be ordered through the GES Service Kit by the exhibitor/organizer including, but not limited to: furniture, floral, catering, electricity, and internet drops.

Suites are available Wednesday, October 9\* through Saturday, October 12 for all four days during regular show hours. All persons accessing the suites must be badged appropriately. Suites are not available on a daily rental basis. *Exhibitor Regulations Apply.*
