Welcome to Florida. We hope your trade show is successful. Since many members of your organization are coming in from outside of Florida, we would like to provide some information to those members that will be bringing in **alcoholic beverages**, **cigarettes** and/or **other tobacco products** into Florida.

In Florida, the above mentioned products are regulated and taxed by our agency. As a result, we must have a complete accounting of the quantity of these taxable products, which are entering our state. We ask that you fill out the attached forms; Application for and Permit to Import Cigarettes/Tobacco, for cigarettes and Other Tobacco Products and Application for and Permit to Import Alcoholic Beverages. You must also attach the corresponding bills of laden to this form. Use the conversion factor of ".26417" to convert liters to gallons if necessary.
