






How does it work?

Lion Leads is an intuitive and reliable lead-retrieval app that makes it easy to take notes and assign qualifiers, helping you speed up the evaluation process.

Every attendee badge includes a QR code linked to that participant's record in the registration database. Simply scan the QR code with the built-in camera on the scanning device and the participant's details (such as name, country, and email) will appear instantly in the app.

Exhibitors can immediately update or complete these details, add notes, and apply predefined qualifiers such as product interests, follow-up actions, or lead status.

All collected data is securely stored on our cloud servers, with real-time access to the backend so you can view and act on your leads without delay.

Administrative Procedure

1. Order

Please order the required number of licenses and rentals according to the early bird and final order deadlines.

2. Order confirmation

After receipt of your order, M Events will confirm the receipt, invoice, and charge the amount due.

3. Configuration of products and services

After payment, you will receive the credentials for the online portal m-anage.com, so you can set up qualifiers prior to the event.

4. Lead capture

Pick up your rental devices at the Registration desk. M Events staff will be available to answer your questions during the event's opening hours. Scanned data is synchronized to the online portal automatically when your device is connected to the internet.

5. Data provision

After synchronization with the database you can access, edit, and download your collected data from the online portal.

Terms and Conditions

Data

Since not all registrants will provide the registration department with complete contact information, we cannot guarantee the amount or accuracy of the user data collected.

Services included

Quotes are per Lion Leads app license and rental device; number of scans is unlimited.

Scanning

Scanning is only allowed at the booth or corporate satellite room. Lion Leads is optimized for and maintained to operate with iPhone 8 and newer devices.

Invoicing

M Events sends out invoices for the total purchase amount after receipt of order. Payment can be made via bank transfer. If the customer requires a PO number to be shown on the invoice, it must be indicated with the order. Later invoice changes due to missing or not correctly filled invoice details will be charged with a handling fee of \$25.

Payment term

Invoices must be settled within ten days after receipt, net without any obligations to M Events. Devices cannot be handed out onsite and no credentials will be sent out unless M Events receives full payment.

Order deadline

After the ordering deadline, M Events does not accept orders automatically but will confirm acceptance separately. For orders after the deadline, a surcharge applies.

Cancellation

Orders cancelled more than 30 days before the conference will be subject to a \$100.00 cancellation fee. No refunds will be provided for orders cancelled within 30 days of the conference. Should the conference be cancelled, clients will receive a full refund for any devices ordered. If the conference transitions to a virtual format, companies participating with either a profile or a symposium will be charged the exact cost for virtual lead retrieval.

Loss or Damage

The cost of a new device replacement (market value) will be charged for lost or damaged iPhones, \$75 per charger/cable.
