

Exhibitor Liability Insurance Program

As a standard requirement for all our show exhibitors, it is necessary for you to carry general liability coverage from an insurance company in good standing with minimum policy limits of \$1,000,000 per occurrence and \$2,000,000 aggregate. Insurance Coverage is not optional.

This insurance must be in force during the lease dates of the event, March 22-29, 2025 naming Association of Equipment Manufacturers (6737 W. Washington Street, Suite 2400, Milwaukee, WI 53214) as the certificate holder. The following must be listed as additional insured: Association of Equipment Manufacturers, National Stone, Sand & Gravel Association, National Asphalt Pavement Association, America's Center Convention Complex, Visitors Commission, St. Louis Municipal Finance Corp, the city of St. Louis, Union Bank, N.A., St. Louis regional convention and Sports Complex Authority, St. Louis county, The state of Missouri, UMB Bank, AMBAC Assurance Corporation, The Bank of New York Mellon Trust Company, N.A, Trustee, their officials, commissioners, trustee, employees and representatives and GES.

Association of Equipment Manufacturers has requested that Rainprotection serve as their insurance management company.
