RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

This waiver and release is freely and voluntarily given with the understanding that I am waiving my and my Minor's right to legal recourse against Informa. My signature on this document is intended to bind not only myself but also my successors, heirs, representatives, administrators, and assigns. I represent that I have the full right and authority to enter into this agreement and bind myself and the Minor to the terms set forth above.
