



RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

I understand that if I have any risk concerns, I should discuss the risks associated with the participation with the activity coordinators and Event staff, before I sign this document and before the activity/Event begins.

In consideration of the Minor's participation in the activity, I hereby waive all claims or causes of action against UBM, arising out of or relating to the Minor's participation in the activity/Event and hereby release, hold harmless, and forever discharge UBM from all liability in connection therewith except such loss or damage which was caused by the sole negligence or willful misconduct of UBM.

I have read this release and hold harmless agreement and understand the terms used in it and their legal significance. This waiver and release is freely and voluntarily given with the understanding that I am waiving my and my Minor's right to legal recourse against UBM. My signature on this document is intended to bind not only myself but also my successors, heirs, representatives, administrators, and assigns. I represent that I have the full right and authority to enter into this agreement and bind myself and the Minor to the terms set forth above.
