These callers are NOT from the official housing bureau and are NOT affiliated in any way with the American Epilepsy Society.

Experient, Inc., the official AES Housing Bureau, will never contact you via telephone to solicit your business. They will only call if you request to speak with someone from their office. Should any other company contact you claiming to be working on AES' behalf, please ignore their solicitation and forward the email or information to [aesgroups@experient-inc.com](mailto:aesgroups@experient-inc.com) so that we may work as a team to stop these solicitations.

Please note that these "poaching" housing companies generally require full prepayment for all rooms reserved, with no recourse for changes, cancellations, etc. AES / Experient is not able to assist on-site with any challenges incurred from booking with one of these fraudulent organizations.
