All shipments to the Advance Warehouse must arrive between October 10 and October 28, 2016. All shipments sent direct to the advance warehouse by other than the Official Carrier will be subject to a local cartage fee in addition to all other fees.

NOTICE

All direct to show site shipments sent by other than GES Canada Logistics must arrive no earlier than 12:00 HRS on October 31, 2016.

Common carriers (over the road freight lines) do not make deliveries on Saturdays and Sundays, unless special arrangements have been made. All shipments by freight, rail, motor freight or air must be "**PREPAID**" and made on a straight bill of lading carefully prepared to show number of pieces, weight, classification, and carrier.

The Official Carrier is responsible for maintaining **IN** and **OUT** of traffic schedules. In order to assure orderly and expeditious handling of exhibit material IN and OUT of the Show, it is suggested that even local exhibitors ship their exhibit material through GES CANADA LOGISTICS, who will have priority at the unloading area, at all times.
