- Le travail sera effectué avec des équipes de deux personnes au minimum, soit l'opérateur de chariot élévateur (dont le coût est inclus dans le prix) et un superviseur (Rigger/Millwright). Afin de maintenir un environnement de travail sécuritaire, une main-d'oeuvre additionnelle peut être nécessaire pour le travail requérant des équipements de levage de plus de 5,000lbs ainsi que pour des situations où plus d'un chariot est requis. To maintain a "Safety First" environment, heavy machinery handling requiring forklift in excess of 5,000 pounds, complex lifts and / or any handling requiring more than one forklift, will require additional manpower for a safe operation. Additional manpower will be assigned at the discretion of GES Canada Ltd, at the cost of Rigger / Millwright. *
